## September 2020 Kindergarten Registration

Dear Parents:

If your child will turn five (5) years old on or before October 1, 2020 he/she is eligible to be enrolled in the Hanover Township Public Schools kindergarten program for September 2020. **Beginning Friday, December 20, 2019**, parents can access and complete the online “pre-registration” forms by clicking on the following link: [September 2020 Kindergarten pre-registration](#) or by visiting our District Website (<https://www.hanovertwpschools.com>), and clicking on the “Student Registration” link located in the upper right hand corner. Parents are asked to complete all online pre-registration forms prior to scheduling an appointment at your respective elementary school.

In-person registration will be held during regular school hours at each of our elementary schools beginning Monday, January 13, 2020, through Friday, January 17, 2020, from 9:00 AM to 3:00 PM. After completing the online pre-registration process, parents will receive a confirmation email and can then call their respective elementary school to schedule an appointment (Bee Meadow School: 973-515-2419, Mountview Road School: 973-637-1550, and Salem Drive School 973-515-2440). Please note, your child must be present at the time of registration.

### School Attendance Zones\*

**Bee Meadow School:** East of I-287, North of Eden Lane

**Mountview Road School:** West of I-287 (excluding Sterling Park)

**Salem Drive School:** East of I-287, Eden Lane and South of Eden Lane (including Sterling Park)

**\*The Board of Education reserves the right to change or modify student attendance zones for the purpose of balancing enrollment or other educational reasons.**

Parents/guardians must provide the following documentation at the time of registration:

1. Proof of the child’s age, i.e., birth certificate, passport (**Original Documents**)
2. Proof of residency, i.e., deed to property, most recent property tax bill, signed contract of sale of property, signed lease/rental agreement
3. A pre-entrance physical examination form completed by the child’s physician
4. Proof that the child received the immunizations required by the Board of Education.

Parents are requested to register their children even though all of the above documentation may not be fulfilled by the date of registration. However, registration will not be finalized until all applicable documentation, forms, and information have been satisfactorily completed and submitted. According to State Law (NJAC 8:57-4.2), your child’s enrollment is incomplete until all required immunizations are submitted to the school nurse for review. Students are not permitted to start/attend school unless official documentation of “proof of immunizations” has been submitted.

Please feel free to contact the school your child will attend if you need clarification and/or have any questions. Additional registration information regarding our District’s Kindergarten Program and Inclusive Preschool Program can be found on our District’s Website (<https://www.hanovertwpschools.com>). I encourage you to visit our website to become better acquainted with the Hanover Township Public School District. You will gain insight as to why we are so proud of our school community.
